TWELVE TEAM DIVISION CHAMPIONSHIP FORMAT: Each team is guaranteed to play three games in the tournament. The division with (12) teams will be placed into groups of three teams each (Groups A, B, C & D) for the round robin preliminary round. Teams were placed into their respective groups based on a random selection using the lotto system to give every team the same chance to advance to MSG. After playing the two prelim games, the top team in Group A & B determined by won-loss record/tie breaker will play a 3rd game to determine the team that advances to the Championship game at MSG. Similarly, the top team in Group C & D determined by won-loss record/tie breaker will play a 3rd game to determine the other team that advances to the MSG Championship game. To satisfy the three game requirement: 2nd place A plays 2nd place B; 2nd place C plays 3rd place D.

<u>Tie breaking procedure</u>: winner of the head-to-head competition between the two teams tied; the total point differential of the teams tied against each other; total point differential of all games played; total points scored; and coin flip further breaks all ties. Note: A maximum point differential of no more than 25 points will be used for the tie-breaker.
