**FOURTEEN TEAM DIVISION CHAMPIONSHIP FORMAT:** Each team is guaranteed to play three games in the tournament. The division with (14) teams will be placed into groups of three teams each (Groups A & B) and groups of four teams each (Groups C & D) for the round robin preliminary round. Group A with three teams will play each other once. Similarly, Groups B with three teams each will play each other once within their respective group. After playing the two prelim games, the top team in Group A & B determined by won-loss record/tie breaker will play a 3<sup>rd</sup> game to determine the team that advances to the MSG Championship game. To satisfy the three game requirements: 2<sup>nd</sup> place B plays 2<sup>nd</sup> place C and 3<sup>rd</sup> place B plays 3<sup>rd</sup> place C.

Groups C & D with four teams each will play each other once within their respective group. Similarly, the top team in Group C & Group D determined by won-loss record/tie breaker will play a 4<sup>th</sup> game to determine the second team that advances to the Championship game. Note: Teams were placed into their respective groups based on a random selection using the lotto system.

Tie breaking procedure: winner of the head-to-head competition between the two teams tied; the total point differential of the teams tied against each other; total point differential of all games played; total points scored; and coin flip further breaks all ties. Note: A maximum point differential of no more than 25 points will be used for the tie-breaker.
